History

-> Founding of the user organization strada in 1997 by Christian Rachbauer and Günther Miniberger

- User representatives in the various districts who exchange information regularly
- Development of self-managed user projects (strada stores, user newspaper, user cafés)
- User office as a low-threshold contact point for those affected

representation of interests according to Oö. ChG 2008

-> user representation becomes the representation of interests that are in the Oö. ChG is enshrined in law

-> pro mente Upper Austria with strada pioneers in Austria to involve clients

->name "strada"

 la strada, Italian for the street, inspired by the classic film "La Strada" (original title: La strada) is an Italian melodrama by director Federico Fellini

Structure and organization

1. Representation of Affected Persons (User Representation) since 1996

- Participation in various expert committees (peer work, UbG, destigmatization of the media, adult representation, ...)
- Networking (regional and national)
- Public relations
- Mouthpiece for people with mental disabilities
- Sensitisation
- Representation on the board of pro mente OÖ

2. Representation of interests according to Oö.ChG

- According to § 35 Oö.ChG, people with disabilities are to be involved in the decision-making processes and suitable forms of representation are to be created, i.e.:
- > The formation of an IV is to be encouraged and supported in the institution
- The IV must be consulted on all important questions regarding the range of services
- Exchange at regular intervals between IV and TL/staff
- > The necessary free time to perform the tasks of the IV must be granted.
- The material expenses of the IV are to be borne by the Land to an appropriate extent.

2. Advocacy for people with mental impairment according to Oö.ChG 2008

- implementation at pro mente OÖ
- approx. 140 IV (representation of interests) elected by the clients of the institution
- approx. 25 BIV (district interest group) elected by IV
- 1 GIV + 1 GIV Deputy (General Spokesperson of the Interest Group) elected by the BIV

-> duration of a "period" is 3 years

Tasks of the representation of interests:

-Representation of the interests of the clients

- to the wearer
- the Province of Upper Austria

-Networking

- IV agreement between the GF and the IV, which was developed in a participatory process and is constantly being adapted
- strada OÖ as a support structure for IV





Networking and exchange

- BIV (Bezirksinteressensvertretung, District Interest Representation) (meeting 10 times a year)
- BIV exam (1x annually, 3 days)
- IV (Interessensvertretung, Representation of Interests) Conference (1-2 times a year)
- Regional meetings of the IV in the districts and regions
- Regular exchange with the team leaders and regional managers
- Exchange of general interest representation (GIV, Gesamtinteressensvertretung) with management
- IV conference of all IV of all sponsors Province of Upper Austria, IVMB
- Networking platform GÖG (Gesundheit Österreich GmbH)
- Meeting with politicians and decision-makers
- Upper Austrian Monitoring Committee
