All "invoices/ packing lists" must include:

- HS code
- If Military goods then please add ML code,
- If Dual use goods then please add Dual use code
- Dimensions, gross weight, net weight
- Exhibition name, date and address

The exhibitor is responsible for all consequences, additional charges and costs resulting from incorrect and/or insufficient details mentioned on the documents!

Customs clearance of NON- EU cargo:

Please provide separate Invoices/ Packing lists for temporary & permanent import goods

1) Definitive importation (brochures, give - aways, samples, other goods to be consumed)

Please issue **INVOICE/ PACKING LIST** for these goods and mention: **NO COMMERCIAL VALUE. THESE GOODS FOR FREE DISTRIBUTION DURING THE EXHIBITION.**

A separate declaration will be made by us on which we will pay import taxes (to be charged to your company).

2)Temporary importation (items to be returned to origin or other countries)

Please issue **PROFORMA INVOICE/ PACKING LIST** for these goods and mention: **TO BE RE- EXPORTED AFTER THE END OF THE FAIR.**

5. Special customs regulations & import prohibitions for strategical goods

Special customs regulations and import prohibitions exist for shipments of a military and defence-related nature, otherwise referred to as Strategic Goods.
