# Learning Lab GREEN – Child poverty: Localising the EU Child Guarantee with Eurochild

5 November 2025, 15:30 - 17:30 CET

### **Background**

Despite political commitments, the EU is not on track to meet its 2030 target of reducing by 5 million the number of children at risk of poverty or social exclusion. In fact, the number rose to **19.5 million children in 2024** – nearly one in four (24.2%). Poverty is not just a socio-economic condition, but a denial of rights, opportunities, and development, in breach of the UN Convention on the Rights of the Child.

The situation varies across countries: rates reach 35.1% in Bulgaria, 34.6% in Spain, and 33.8% in Romania, and are also high in high income countries such as France (26.2%) and Luxembourg (25.6%). In the EU enlargement countries, the figures are even more concerning, with child poverty affecting 40–65% of children in Albania, Türkiye, and Ukraine.

14 June 2025 marks four years since the adoption of the Council Recommendation establishing a European Child Guarantee (ECG). The ECG provides a clear framework to address these challenges, ensuring children's access to free healthcare, inclusive education, nutritious food, adequate housing, and early childhood education and care.

Since championing this initiative in 2015, Eurochild has remained a leading civil society voice for its effective implementation and monitoring. We have tracked the development of the National Action Plans and are now producing overviews of the biennial implementation reports published by Member States.

Cities are crucial actors in delivering the European Child Guarantee. Being closest to children's everyday realities, they are uniquely placed to address inequities and ensure access to essential services. Their ability to connect sectors such as education, health, housing, and social protection allows them to provide more integrated and holistic support. At the same time, cities act as incubators of innovation: they can pilot solutions that respond to local needs and later be scaled nationally. By carrying out needs assessments and collecting data at the local level, cities also play a vital role in monitoring progress and shaping evidence-based policies.

This workshop will explore how local authorities can use the European Child Guarantee as a practical tool to reduce child poverty and exclusion, build integrated service delivery, and strengthen collaboration with national governments and civil society, and will include a presentation of Barcelona's fresh Strategy to combat child poverty for the period 2025-2030.
